






RESOLUTIONS OF 11TH GOVERNING BODY to CLPT

Report of Chalapathi Institute of Pharmaceutical Sciences (01/10/2023 - 29/12/2023)

Respected members of the

GB;

I am honored to present a comprehensive report of Chalapathi Institute of Pharmaceutical Sciences from October 1, 2023, to December 29th, 2023. Following the 10th Governing Body held at Chalapathi Institute of Pharmaceutical Sciences, in October 2023, seven resolutions addressing research and development cell, curriculum enhancements, seminars, conferences, CO-PO attainments of Vision-Mission Committee and 09 resolutions related to IQAC, 04 resolutions related to 10th and 03 resolutions of 11th finance committee were discussed and implemented. The academic activities for B.Pharmacy/M.Pharmacy/Pharm.D programs for the academic year 2023-2024 are currently in progress, and all examinations for the preceding academic year (2022-2023) have been successfully completed. Over the span of three months, the institute showcased with the publication of 05 research papers, (02 in Web of Science (WOS)), published 01 book, 01 book chapter. During this period 05 faculty awards, one guest lecture was delivered. We acquired advanced *gas chromatography*, conducted a total of 03 *guest lectures*, 04 webinars which provided students with insights from industry experts and academic luminaries. Our institution further contributed to skill development through 01 *skill development course*, enhancing students' practical knowledge and employability. Additionally, the establishment fostered industry-academia collaboration by signing five Memoranda of Understanding (MOUs) with Solution 3X, Greyhound Chromatography and Allied Chemicals, Bhuvika Healthcare Pvt Id, RVJ Pharma Consultants private Limited and Leo Global Overseas. 03 Career guidance sessions, 14 awareness programs, 02 industrial visits, and a national pharma quiz added further dimensions to the institute's comprehensive approach to education and skill development. 16 outreach activities were organized and benefitted 1274 people. To foster intellectual growth and knowledge sharing, we organized 3 *conferences* and 02 *workshops/hands-on training activities*.

4. Resolved to consider and approve the payment of 30% of consultancy fee to teaching staff (if the consultancy fee is more than Rs. 5000/-), who are actually engaged in consultancy projects.
